Charlie Braccio was a beloved husband of 39 years, father, brother and friend whose legacy of resilience and perseverance lives on forever.

He was a committed postal worker for forty years. He selflessly dedicated his life to his wife and two daughters, even if it meant working and traveling long hours through the coldest and darkest of days. He beat cancer in 1997 but scathed with chronic excruciating pain he fought through life without a single complaint and a smile on his face. Even in these circumstances, he was relentless in providing for his family.

Music was Charlie's passion. As an avid collector with an old soul he amassed thousands of records and albums -- the likes of Johnny Maestro, swing, doo wop and R&B. He could tell you every detail of each artist and the story behind them. He still possesses his first record from age 12. He also enjoyed sharing his knowledge about old noir movies.

Charlie has touched the lives of countless people whether it be striking up a conversation with a stranger at the grocery store or whipping up a custom mixtape for his friends and coworkers. He was such a genuine and thoughtful person whom everyone knew and loved effortlessly. Charlie will always be remembered.

Survived by wife Christine and daughters Nicole and Olivia.

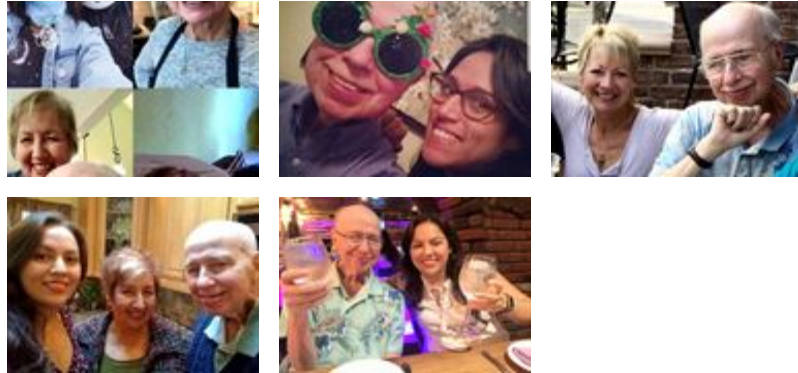
